VERIFICATION REQUIREMENTS
Items preceded by an asterisk need to have proof submitted by a club representative by the date shown to win points. Most verification can be done with any medium that shows the task was accomplished. Photocopy, PDF, screenshot, email, etc. Increase in Membership will be completed by AAF District 6 using last year's dues invoice. Increase in Award Entries will be completed by AAF District 6 through OpenWater Software.
